Broadloom Carpet as detailed on our current range statement.

Description of Broadloom Carpet

The term broadloom carpet is taken to mean carpets that are woven on a wide loom and are installed wall – to – wall. Belgotex (NZ) Ltd supplies broadloom carpets made from a synthetic fibre pile or a natural wool pile. The pile is woven into a primary backing material of polypropylene or jute which is bound with latex adhesive.

Broadloom carpets are supplied in full rolls between 2.00m to 5.00m wide. Partial rolls are also available.

When installed a Belgotex (NZ) Ltd broadloom carpet may contribute to G6 (airborne & impact sound) of the building. Compliance with this clause would need to be established as part of the proposed flooring system.
